**WARRANTY POLICY**

Aerotech of Louisville, Inc. Warrants that all Aerotech of Louisville overhauled alternators, generators, starters, starter adaptors, starter generators and other units sold by Aerotech of Louisville, Inc., shall be free from defects in material and workmanship under normal use and service until one (1) year or 250 hours from date of installation into the aircraft, if, and only if, the following conditions are met.

1. Units must not be disassembled and in their "as removed" condition.
2. No substitute parts shall have been installed in the product.
3. The product shall not have been disassembled, repaired or altered outside of Aerotech unless written prior authorization was granted.
4. The product shall not have been subject to misuse, accident or improper installation.
5. The product shall not have been damaged due to an overcharge, overcrank or engine kickback condition.
6. Copy of log book entry.

The sole responsibility and liability of Aerotech, Inc. is the repair or replacement of the defective unit. In no event shall Aerotech of Louisville, Inc. be liable for any special, consequential, incidental or penal damages or expenses, revenues, loss of use of the product or any associated equipment, damage to associated equipment, cost of capital, cost of substitute products, facilities or services, down time or cost of claims of third parties for such damages or expenses.

Acceptance and installation of the product by you shall constitute your acknowledgement and acceptance of the terms, provisions, limitations and exclusions set forth herein. Such terms provisions, limitations and exclusions shall not be modified, deleted or supplemented except by the written acknowledgement of Aerotech of Louisville, Inc.

All products returned are to be shipped to Aerotech of Louisville, Inc. If the warranty claim is accepted, the repaired or replacement part will be shipped surface freight prepaid.

Exception: Rabco Drive Part Number 641500 (CC150) has a 6 month or 75 hour full warranty.

**CORE POLICY RETURN**

Any unit being returned for core or warranty credit shall be as removed from the engines, complete and not disassembled. No core or warranty core credit will be allowed for automotive units. Units that are rusty or cannot be overhauled for any reason will be classified as scrap, having no value. Units which have been weld-repaired, as well as units which have been disassembled and then reassembled with old parts will also be classified as scrap, having no value. A percentage of the core value will be charged for all missing or damaged parts. At no time will the damaged or missing parts charge, on any unit, exceed the core value of that unit. Cores must be returned within 60 days from date of purchase.
